1. After an application is approved, full payment within 7 days of invoicing will be required to confirm the stall allocation.
2. **Once stallholders have paid their invoice, there will be no refund for that market date.**
3. Depending on space available:
 - each stall location is determined by the Events Coordinator on a monthly basis,
 - stalls may be allocated inside the venue OR outside in the beer garden (under marquees provided by Polonia), and
 - a priority for inside will be for stall holders with perishable/delicate goods.
